In early January the tax administration of the Canton Bern will send you the tax forms for the 2025 calendar year.

If you would like to authorise us to complete your tax declaration, please send us these forms as soon as possible after having received them.

In addition we will automatically extend the deadline for your tax declaration if needed.

As a reminder, here is the list of the documents that you should bring along to your appointment or submit to us:

- Annual salary statements 2025
- Certificates of unemployment benefits 2025
- Certificates of daily accident and sickness benefits paid out
- Certificates on pension payments AHV and pension fund 2025
- Contributions to a restricted private savings scheme Pillar 3a and/or buying into an occupational pension fund made in 2025
- Invoices professional training costs paid by yourself
- Membership fees in professional associations
- Marketable securities and their revenues in 2025 (possibly tax or custody account statements from your bank)
- Values, Bankaccounts or property of any kind abroad
- Interest statements for all saving accounts incl. closed accounts 2025
- **Did you own Bitcoin or any other cryptocurrencies in 2025?**
- Do not forget recently opened accounts and loans
- Lottery payouts 2025
- Surrender values of life insurance policies: Please enclose the certificate of the insurance company as at 31.12.2025.
